

End of the EHC Needs Assessment

If the LA decide a plan is NOT necessary – notified within 16 weeks of the original request

If the LA decide a plan IS necessary – a draft plan is prepared





Options following a refusal

- Meet with the LA to discuss
- Mediation
- Appeal to the SEND tribunal

Planning Meeting

The purpose of a planning meeting is to:

- look at an initial draft plan
- share your views
- ask questions to make sure you understand
- explore and agree possible amendments

This outcome isn't very clear.




An EHC plan can only be issued after a child, young person or adult has gone through the process of EHC needs assessment.

At the end of that process, the local authority has to decide either to issue an EHC Plan or not.

It will issue an EHC Plan if the CYP or adult has a **special educational need or disability** that cannot be met by the support/advice which is usually available to their school or college.
